23. CANADIAN PENSION PLAN – CHILD REARING DROP-OUT PROVISION (STAYING AT HOME TO RAISE YOUR CHILD) (also available in French)

The Canada Pension Plan includes a provision for parents who stay home (or reduce their earnings) to care for a child. The Child Rearing Drop-out Provision protects parents against significant reductions in their future pensions (Service Canada, 2008).

25. SPECIAL SERVICES AT HOME (also available in French)

This program (Ministry of Child and Youth Services, 2007) helps families pay for special services in the home or outside the family home as long as the child is not receiving support from a residential program. Families can hire someone for helping their child learn new skills and abilities or do more of the daily living activities on their own. It can also include respite services.
